Definitions and interpretation

1. In this privacy policy, the following definitions are used:

 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";

- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Sarah Sivers, trading as Liminal Space Psychology Service Ltd and Users with respect to this Website. Data collected

Data that is given to us by you
